Here's our March Update for the All Gals Golf Club 2024 Season

We're just days away from our first tournament of the season at Callippe. Looks like we will have a great turnout of ladies.

Since we are still in wet weather season we will be playing "winter rules" – Lift, Clean and Place.

Here are some helpful tips on how to proceed. Remember this applies to the "general area" of the course, defined as

The area of the course that covers all of the course except for the other four defined areas: (1) [the teeing area](#) you must play from in starting the hole you are playing, (2) all [penalty areas](#), (3) all bunkers, and (4) [the putting green](#) of the hole you are playing

1. **Mark the Position of Your Ball** -using a tee to mark your balls location
2. **Lift and Clean Your Ball**- you may clean any water or mud off the ball
3. **Place Your Ball**- placing the ball within 1-club length or within 6" (or scorecard length)

ADDITIONAL EXAMPLES

The bunker is filled with water – what are my options?

When the bunker is filled with temporary water, you may play your ball as it lies or take free relief in the bunker. When taking free relief, you must find the nearest point of complete relief in the bunker and drop within the one club-length relief area (see Rule 16.1c(1)). If complete relief is not available, you may take free maximum available relief in the bunker and drop within the one club-length relief area from the point of maximum available relief (see Rule 16.1c(1)). Additionally, for one penalty stroke you may drop a ball outside the bunker by going back-on-the-line as far as you'd like keeping the point where your ball lies in the temporary water between you and the hole.

Ball is stuck in the ground (embedded-general area) – what are my options?

You may play it as it lies or take free relief by dropping the ball within one club-length of the spot right behind where the ball is embedded. (Rule 16.3a)

Embedded Ball in (general area) but can't be found – what are my options?

A soggy fairway can swallow your ball entirely and leave no trace. If this happens to you, you may be entitled to relief.

If you get to your ball's landing spot and find an abnormal course condition — such as temporary water or ground under repair — but can't find your ball, you are entitled to free relief if you can meet the *known or virtually certain standard*. Known or virtually certain means that "either there is conclusive evidence that the event in question happened to your ball, such as when you or other witnesses saw it happen, or, although there is a very small degree of doubt, all reasonably available information shows that it is at least 95 percent likely that the event in question happened."

Good luck ladies and don't forget to review the USGA Video Rules

Each month NCGA posts a RULE OF THE MONTH. Here is this month's first Rule, which may be timely given our tournament is in March.

Rule of the Month: Abnormal Course Conditions/Embedded Ball

The rainy season is here, which means you may occasionally find your ball in a puddle or plugged in the turf? What now?

Certain conditions are not treated as part of the challenge of playing the course, so free relief is provided as an option. This includes interference from temporary water, ground under repair, animal holes, and immovable obstructions (such as carts paths and sprinkler heads). All of these things are collectively known as abnormal course conditions. You get free relief when the condition interferes with your lie, stance, or area of intended swing. When an abnormal course condition only interferes with your line of play, free relief is not provided.
